RE: Crown - China Investigation

We refer to our letter dated 1 March 2019.

As foreshadowed, Crown has undertaken a review of the subset of key documents discovered to date which it had identified as most likely to be of relevance in the class action.

Among these materials, Crown has identified 85 documents that are caught by the VCGLRs notices. Details of these documents, along with the notices to which Crown considers these documents to be responsive, are contained in the annexure to this letter.

To assist you in understanding the materials produced, we make the following comments:

- some of the emails produced in this tranche of materials resemble correspondence already provided to the VCGLR to date. These emails are different threads of correspondence which may differ slightly to the versions previously provided;
- some materials in this tranche have been redacted for legal professional privilege. Consistent with the VCGLR's previous requests, we have not redacted any materials other than for legal professional privilege;
- (c) where a document provided was originally an attachment to another document (**Host**), we have set out the document ID of the Host in the annexure below in order to illustrate that relationship.
