My name is Timothy Bryant and I work for the Victorian Commission for Gambling and Liquor Regulation (VCGLR) in Australia.

The VCGLR are responsible for ensuring that Crown Casino (Crown) in Melbourne is operated within the relevant laws of Victoria, Australia.

The VCGLR are currently conducting an investigation into the circumstances of the detention of Crown employees in China in 2016.

I would like to discuss with you what happened to you when you were working for Crown in the events leading up to your detention.

I would like to stress that the enquiries we are conducting are about your previous employer, Crown, and not you as an individual.
