## VCGLR China Investigation - detention of Crown Group Staff in China

We refer to our letter dated 21 September 2018 which enclosed 4 Volumes of documents provided in response to your letter dated 23 August 2018.

On page 8 of our letter we described the document review process being undertaken in respect of the 'T2 dataset'. That process is continuing and production of documents from that data set to the lawyers for the class action applicants is in progress.
