I refer to your 24 December 2018 letter regarding Recommendation 1 and proposal.

The VCGLR requests clarification and further information.

- Has the new Crown Melbourne Executive Risk and Compliance Committee replaced the Crown Melbourne Risk Management Committee as referred to in the Sixth Casino Review report?
- Crown Melbourne Compliance Committee. Given that the number of members is split
 equally between executives (two) and independent directors (two), how are resolutions
 passed if the votes are tied. Does the independent chair have casting vote? (or does the
 voting outcome need to be unanimous?) The charter is silent.
- Crown Melbourne Board. Given that the number of members is split equally between executives (three) and independent directors (three), how are resolutions passed if the votes are tied?

Clause 20.9 of the Articles of Association – 'Majority decisions' requires that "Every question and resolution dealt with at a meeting of the Board is to be decided by a majority of votes of the Directors who are entitled to be present and to vote on the question or resolution". Does the Executive Chairman have the casting vote on all questions and resolutions? Clause 12.14 refers to casting votes on ordinary resolutions.

 Line 11 of page 10 of the Recommendation One Proposal document. Should "Those Crown Melbourne Board Committees in turn report to..." read "Those Crown Resorts Board Committees in turn report to..."?
