Dear Mr Phillips and Ms Gill

Royal Commission into the suitability of Crown Melbourne Limited to hold a Casino Licence (Commission)

We refer to:

- Notices to Produce references NTP-001, NTP-007, NTP-009, NTP-010, NTP-016, NTP-018, NTP-020, NTP-021, NTP-029, NTP-031 and NTP-039 (the Notices); and
- your letter dated 16 April 2021 (Letter).

We will shortly send you a link to a production which contains documents that are responsive to a number of categories of the Notices. The Schedule to this letter contains a summary of the current status of production of documents responsive to the Notices, including reference to documents previously produced, those in the current production and the status of the outstanding documents. Those items shaded in grey are categories where Crown's production is now complete or where Crown has provided the key documents and does not intend to take further steps at this stage unless the Commission requires any additional information.

Unfortunately, in the short time available since receiving the Letter for particular documents by midday today, it has not been possible to review and process all of the requested documents, although a significant number of the categories requested will be satisfied by the documents in today's production.

In terms of the other priority categories referred to in the Letter, Crown is progressing these as a matter of urgency to provide to the Commission as soon as possible and will make further productions before Friday, 23 April 2021. In this regard:

- A number of priority categories are those which relate to communications with CPH and/or James Packer. A document review team commenced review of these documents several weeks ago. However, given the breadth of these requests, it will take further time to satisfy them fully. Crown will produce an initial tranche of these documents this week. If there are custodians or time periods which should be prioritized, please let us know.
- Many of the categories requested by the Commission seek 'Reports', which are defined to
 include materials provided to the Boards and Committees of Crown Resorts and Crown
 Melbourne. Crown made a proposal in its letters dated 8 and 16 April 2021 which was
 intended to allow Crown to get this type of material to the Commission promptly and

- efficiently. To do so, however, Crown requires a further Notice. We would be grateful if the Commission would issue this Notice so that the documents can be produced.
- Crown sent letters to the Commission on 25 March and 8 April 2021 asking for further
 clarification in relation to privilege. These letters remain unanswered and this is an issue
 which impacts a number of categories of documents, including those contained in the
 Commission's list of priorities set out in the Letter. We would be grateful if the Commission
 could respond to this letter as soon as possible so that Crown can take the appropriate
 approach to privilege in respect of any outstanding documents.

To date, Crown has received a total of 22 Notices from the Commission. These Notices contain an extremely broad set of requests going back more than twenty-five years and requiring significant effort to collate, review and process for production. Crown has proceeded in good faith to comply with these Notices in what it has perceived to be the most effective and helpful way and, prior to the Letter, in the absence of any guidance from the Commission as to its priorities. In order to do so, Crown has already provided the Commission with the majority of the documents that were produced in the Bergin Inquiry (in total 27,251 documents).

The table containing the status of production in the Letter suggests that Crown has not produced documents responding to many categories of the Notices. As explained to you in our letter dated 23 March 2021, Crown prioritized the production of documents responsive to NTP-009 and NTP-010 category 2 (which called for those documents produced in the Bergin Inquiry) because those documents also responded to a significant number of the Commission's requests (including many of those noted in the Letter) and would allow Crown to assist the Commission by providing as many documents as possible, as quickly as possible. Crown therefore directed its resources to preparing those documents for production as a priority whilst progressing other aspects of the Notices in parallel. As the Schedule demonstrates, this set of documents contained a large volume of relevant material across categories and Notices beyond what was set out in the Letter.

We would be happy to discuss any of the above matters further to ensure that the approach adopted by Crown continues to be helpful to the Commission.
