

#### Self-Exclusion Inquiry

13:00 received a call from an Asian male who introduced himself as inquiring about the Self Exclusion process so he may assist his sister in-law (no name provided) who is allegedly experiencing difficulties with her gambling behaviour.

It was alleged by the caller that his sister in-law is in debt \$60,000 to loan sharks operating with the casino. It was further alleged that she has been in debt in the past, for smaller amount but the family has always come to her aid and paid the amounts owed.

The S/E and revocation process was explained in detail as were the possible consequences for breaching a S/E Order.

The services of the RGSC and in particular the availability of a RGC to family members of people experiencing difficulties with their gambling was offered.

Location and contact details of the RGSC were provided and it was implied by the caller that he will endeavour to discuss the benefits of proceeding with S/E with his sister in-law.


