He asked security for Tissues to clean his blood on the neck and face. Security noticed broken glass on the floor at pit 85. The Victim refused any Police to attend the location. He requested for the medics to attend and look his wound , if he need to go to the hospital. Crown Medics was requested . Surveillance had the coverage of this incident. Zulu Tyson attended the location, the old bandage was removed and the blood has stopped. The wound on the right cheek was cleaned and new bandage was applied. The male was told to see his doctor for further treatment. The victim was allowed to stay on site as per the VIP gaming manager. Communication center reported the offender left the location before the security arrived at level-29. No further action.</p>
